Administrative Reports.....

MAYOR'S REPORT/REQUESTSMAYOR JOEL B. DAY

Mayor Day had the following report:

- Urge Passage of Ordinance 2-2017 to Acquire the Coniglio Property:
I would ask Council to approve Ordinance 2-2017 after its third reading tonight to accept the donation of the former Riverview Welding property on South Broadway from Joe and Cheryl Coniglio. Acquiring this property is key to the future development of the Waterworks Fields and the Ohio-Erie Canal Towpath Trail through New Philadelphia. In addition, Council's approval of Resolution 2-2017 will allow the City to apply for Clean Ohio grant funding, that will be used to construct the towpath and a trail head on the property. Quicksall and Associates is assisting in

the design plan and grant submission. My plan is to bring the towpath trail through New Philadelphia, construct boat ramps at the Waterworks and Carlisle property locations, and create a recreation economy by encouraging canoeists and kayakers to use the Tuscarawas River, and bicyclists and walkers to utilize the towpath.

➤ **Developing a Maintenance Agreement for the Crider Avenue Park:**

On January 27th Service Director McAbier and I met with New Philadelphia Schools administrators to begin developing a joint maintenance agreement for the Crider Avenue park. A parking lot and nature walk trails will be constructed on the property, which will be used as an outdoor classroom. The cost of maintaining the park will be shared by the City and the school district.

➤ **Welcome Kinder Morgan to New Philadelphia:**

On January 31st I had the honor of welcoming executives, employees and sub-contractors of Kinder Morgan to New Philadelphia at a morning gathering at the Schoenbrunn Conference Center. Kinder Morgan selected New Philadelphia as its headquarters while it constructs the Utopia natural gas pipeline from Harrison County through northern Tuscarawas County. The project will bring a short term boost to our local economy. But from what I've learned from Kinder Morgan officials and experts at a recent East Ohio Development Alliance conference, now that pipelines are being built, the oil and gas business is making its return to Eastern Ohio. I'm told that oil drilling in Tuscarawas County is still several years off. In the meantime, our challenge will be to capitalize on this opportunity and find ways to entice executives, workers and their families to take up residence in New Philadelphia. The fact that Kinder Morgan is here is a start.

- **“State of the City” Report is Under Development:** Now that I've received 2016 year end reports from all department heads, I am crafting a “State of the City” report for City Council. It is my intent to have it ready to present by the February 27th Council meeting.
- **One Eyesore Down, More to Go :** It was a welcome sight last week to see the demolition of the former Clark/Eagle gas station get underway. The property was purchased at Sheriff's sale by JNG Grill owner Ron Rosenthal, who plans to use it to expand the JNG to include an outdoor patio and additional parking. It's been a year since I initiated foreclosure proceedings on the former owner to get to this point. I have instructed Service Director McAbier to have his office identify other neglected properties in the City that can be targets for foreclosure.
- **The Salvation Army Expands Its Outreach to the Homeless:** Lieutenant Andrew Allen of the Salvation Army and Jack Ream of the local Friends of the Homeless shelter have informed me that they have opened an emergency drop-in shelter at the Army's church on Emmet Avenue NW. The facility will only be open from 9pm to 6am to take in temporary homeless individuals and families. Mr. Ream said the Salvation Army location is necessary because the homeless shelter downtown is filled and does not have room to accommodate people who just drop in looking for shelter. According to Mr. Ream and Lt. Allen, homelessness remains a big problem in Tuscarawas County. Contact Friends of the Homeless and the Salvation Army if you feel the need to support their effort.
- **Volunteered the City Health Board to Offer Budget Testimony to the Ohio House :** I have written an email to State Representative Al Landis, offering to have myself and members of the New Philadelphia Board of Health travel to Columbus to testify before an Ohio House subcommittee considering Governor Kasich's new biennium budget. City Health Commissioner Vickie Ionno has been keeping the board informed of the Governor's attempt to force accreditation and consolidation upon local health departments. The board members feel strongly that accreditation is unnecessary and too costly, and to use it to force health departments to consolidate would threaten the closure of our Health Department, and deny access to health services to the people who need it most: low income individuals and families.

Mr. Ricklic had the following question for Mayor Day:

What are the numbers they can handle overnight at the Salvation Army's church?

Mayor Day had the following response:

I do not recall an exact number but maybe around 18.

Mr. Zucal had the following question for Mayor Day:

What's there plan? Just to help them find housing outside the County or is it? They're in transit and they're going to provide an overnight?

Mayor Day had the following response:

They're in transit and they're going to provide an overnight for shelter. They're terming it an emergency. It's a "one shot deal". They can stay one night because of the temperatures are too cold and they need emergency shelter immediately they can go there.

Ms. Ramos had the following question:

The Developing of a Maintenance Agreement for the Crider Avenue Park, do you know how much that's going to be?

Mayor Day had the following response:

We don't know yet. We haven't constructed anything out there.

Ms. Ramos had the following question:

At the last report you gave us the banks were coming in to do bids for the loan for the new airport hangars. What happened with that?

Mayor Day had the following response:

We received those last Friday and Service Director McAbier and I are reviewing them tomorrow. Then we'll approach the Council President to assign it to a Committee to review. We asked for a loan for \$450,000.00 to cover the cost of construction plus contingency.

SERVICE DIRECTORMR. RON MCABIER

Mr. McAbier had the following report:

- I just wanted to give an update on the LED lighting we have downtown. We have a section done now, I don't know if anyone might have noticed, between 3rd Street and 2nd Street on West High, north and south sides are both done. The \$35,000 check from AP came in so they are all ordered from Fenton Brother's Electric. When they get in John Schmidt from Wood Electric will install them. So, I look for hopefully by the end of March hopefully John will have them all done, weather permitting, because John's on his little lift so he's doing it to save us some money. Also, the new garbage truck will be here tomorrow, which is good news. Finally, leaves are done throughout the City. We hit most of the City twice, some areas I know I saw guys come back three or four times because of the way they fell this year. If anyone would have a question, we are being asked to tell people to bag leaves and they'll pick them up on the garbage route. General Services is now concentrating on patching and trees.

Mr. Vandall was just extremely well respected and he has two great sons who I went to school with, and wonderful grandchildren. We just lost a tremendous talent that was right here in our midst. He was very unassuming and did a lot of great and was a fantastic ambassador for the City of New Philadelphia.

FINANCE COMMITTEEMR. DARRIN LAUTENSCHLEGER

Mr. Lautenschleger had the following report:

The Finance Committee met this evening in Council Chambers with 3 items on the Agenda. One was Proposed Ordinance 5-2017 which deals with the annual permission for the Administration to handle the bids for materials and supplies for various departments. The Committee agreed to place that on the February 27, 2017 Agenda for 1st Reading, suspend the rules and recommend passage on 1st Reading. The 2nd item was Proposed Ordinance 4-2017 which you'll see on the Agenda for 1st Reading this evening which authorizes the City Service Director to solicit the bids and award a contract for the City's CDBG Project for 2016 Project Year to be done in 2017. Mr. McAbier provided the background on the project and answered questions about that as well. The Committee agreed to place that on the Agenda tonight for 1st Reading and approve after 3 Readings. The other item was Mary Kurtz the Director of Human Resources joined us and explained an update to the City's non-bargaining wage study which we had started work on during the month of

January. Since the original meeting and the initial recommendations that were presented Ms. Kurtz and the City have employed a new HR Consultant. He's reviewed materials and has provided some updates. It was requested that he meet with the Committee at an upcoming meeting. We're going to have the Law Director touch base with him since he is an attorney, get back to us, and we will schedule a meeting and start to dig in to some of the details and see where we're at. So, there was no action taken on that and the meeting was adjourned at 6:56pm.
