ART CICCONETTI Reported that the Committee took under advisement the liquor permit request for Ikon, Inc., and approved it without holding a formal meeting. SPECIAL COMMITTEE. MR. TOM LOCKER NO REPORT VISITOR'S COMMENTS: Virginia Burkholder, 555 Rankin Ct. S.W., New Philadelphia, presented a petition from residents of Rankin Ct. asking that their street be repaired. Merely paving it would not alleviate the problem that exists, it needs to be rebuilt.

Bill Heaton, 834 3rd St. S.E., New Philadelphia, said it was brought to the attention of residents in that area that there was a lot split behind 837 2nd St. The application was first rejected, and was later approved by the Zoning Board of Appeals. Two duplexes are to be built there, and the residents presented a petition against this because there are questions as to the right of way for the alley. Law Director Mike Johnson advised the residents they have 30 days to appeal the decision made by the Board of Zoning Appeals; however, Service Director Gary Espenschied

said the lot split was done over a year ago. Mr. Espenschied will check with the Law Director to determine what can be done.

Ella Slough, 616 Sandpiper, S.E., New Philadelphia, asked that a hole on East High Avenue and Beaver Avenue be filled in. She asked about changes being made at West High Ave. and Tuscarawas Ave., 4th St. and West High Ave., and Beaver Avenue and East High Avenue. She asked if the synchronization of the lights downtown has changed. She complained about the condition of a property on Ashwood Lane and 5th Dr. N.W., and asked if the Health Department would investigate. Council member Jim Locker said he went to that property, and it is a mess. Safety Director said a police officer on dayshift is working on this, and he has contacted Mr. Ulis in the Health Department. Ms. Slough asked why is the airport going to be used for races. President of Council Dave Johnson said that issue will be put into committee for review.
