ADMINISTRATIVE REPORTS:

MAYOR'S REPORT/REQUEST......MAYOR MICHAEL TAYLOR

Mayor Taylor addressed the following:

- Mayor Taylor requested a short Executive Session after the Legislation to update Council on Collective Bargaining with AFSCME and to also discuss potential Land Acquisition.
- Mayor Taylor reported the Tuscarawas County Chamber of Commerce co-sponsored with the City an informational session on our Airport held August 14th, 2012. Mayor Taylor thanked Scott Robinson and the Chamber for being willing to work with us to invite their membership base to this event. Mayor Taylor reported there were approximate 40 people in attendance. The City Airport Consultant gave a presentation on issues at the Airport and answered follow –up questions.
- Mayor Taylor reported he recently met with officials from ODOT to discuss the proposed West High Widening Project scheduled for 2014. The meeting was an opportunity to get everyone up to date on issues on what needs done to move this project forward. There was discussion about the paving for 2013 on State Routes in the City. ODOT is compiling additional information on estimated costs that are 100% of the City's. When an accurate estimate is received; we will be able to determine how much paving that we will be able to do from our budget. Mayor Taylor announced that one major issue affecting this program is what amount of curb radius work will be required which is all paid for from City Funds.
- Mayor Taylor reported that last week there was a meeting regarding the traffic study on the University Drive/East High Avenue area. The Mayor announced that "TMS Engineering will prepare some preliminary estimates of costs to do some Engineering Plans as a first step and depending upon those numbers, we will determine what and when that

might occur." The Mayor's goal is to slowly get in front of projected growth in that area and to be ready as it comes rather than react to it after the fact.

Question: Council Member John Zucal was curious as to whether or not we had heard anything in regard to the NRG (Neighborhood Revitalization Grant.)

Mayor Taylor replied the NRG was declined but the CDBG (Community Development Block Grant) Program on Maple Avenue will move forward.

Ms. Cox made a motion to have a short Executive Session after the Legislation to discuss Collective Bargaining with AFSCME and to also discuss potential Land Acquisition as the Mayor's requested.

SERVICE DIRECTOR......MR. JAMES ZUCAL

The Service Director reported on the following:

- The Service Director reported the NRG Program for the West School for next year was not funded. The Director of the program told Mr. Zucal it was decided based on a scoring system. They will post in November on how we finished out in that application. There were 16 applying state wide for that program.
- There was one application for the Airport Consulting Services and that is from the Baker Company who is our current Airport Consultant. It is a five year contract.
- The Service Director has been involved with union negotiations the last several weeks with AFSCME Service Union
- In regard to the Moving Ohio Forward Demolition Program; the Service Director reported that he was contacted by the Ohio Regional Development Corp in Coshocton with our application and was told that program is not for commercial or business structures but for residential only. The key is structures, on our Housing Review Team they use the word identify we have identified those structures but none of the commercial (two commercial) business type structures are not allowable under the program through the Attorney General's Office.

Question from Council Member Winnie Walker "will you replace these with somebody else?"

Mr. Zucal replied "I don't think so at this point; the 6 structures that are left may not all get funded. We do have to front the money and then get reimbursed."

SAFETY DIRECTOR......MR. GREG POPHAM

The Safety Director reported on the following:

- Civil Service Entrance Exam for the New Philadelphia Police Department was administered Wednesday to 26 applicants. Mr. Popham announced that is just the beginning of the process; there are seven more testing phases to go through.
- The Safety Director reported the Fire Department is almost completed with all the school inspections there are only (2) that are remaining and they were going to do them tomorrow.
- Mr. Popham reported that Thursday of last week, Officer David Cimperman submitted a retirement resignation letter effective noon August 23rd, 2012. After 17 years of service, Dave is no longer with us.
- A Veterinary from the Town and Country Veterinary Clinic has informed us that K-9 Striker has a medical condition and that he should not be a work dog anymore. Striker has gone back to the people that originally gave him to us. He was actually given to us; traded -in for Ruger who was before him. Sergeant Rossi, K-9 handler, is in the process and has a pretty good handle on the possibility of a donation for another work dog. The Safety Director announced there should not be any cost to the City but if there is it should be minimal. (There is a K-9 Fund established for that purpose.)

The Law Director reported he has been in contact with Honorable Judge DeGarmo VonAllman, from the Municipal Court. The Court is in the process of entering into a contract with Capital Recovery for the purposes of a collection agency. The Judge has worked extensively in drafting the contract. The Law Director informed Council that he has already read through it and gave his preliminary approval to it.

The Law Director reported the Court is authorized to do this under Ohio Revised Code 2335.24 which also requires City Council approval. The Law Director is requesting that the President assign that to a Committee and the Law Director will draft appropriate legislation and include a copy of the contract. Honorable Judge DeGarmo VonAllman requested that she be notified when the Committee meets so she will be able to attend the meeting to answer any questions. The Law Director informed Council that this is the same company the Common Pleas Court is associated with. The Law Director informed Council that it doesn't cost the tax payers anything. All of their money is derived from a percentage of that what they collect.
