VISITOR'S COMMENTS:

Ms. Ella Slough, 616 Sandpiper, S.E., New Philadelphia, asked if anything could be done about the noxious odor coming from the wastewater treatment plant. She asked if the signs which prohibit bicycle riding within a block of the downtown area still exist, and could be put back up. She read an article from 1922 concerning signs on trees and poles, and said there is still a problem with that issue. She asked if the Airport Restaurant is current on their payments to the City, is the timber to be sold from the south side park land, and is work to be done at 4th St. and West High Ave. and 4th St. and East High Ave. She publicly acknowledged Sandy and Mark Cox for taking her to the hospital and staying with her during her recent illness. Mr. Jim Locker said the Airport Restaurant has experienced some slow months, but they are current in their rent payments. Mr. Espenschied said Issue #2 money will be used for improvements at the intersections in question, and the timber is from the south side park. Mayor Brodzinski will check on the signs concerning bicycle riding downtown. Mr. Espenschied said the wastewater treatment plant is being upgraded, and they are addressing the odor problems. Safety Director Greg Popham said the police are removing signs from poles and trees when they see them.
