Roll call, 7 yeas, ordinance passed.

- 9-2008 An ordinance to make appropriations for current expenses and other expenditures of the City of New Philadelphia, State of Ohio, during the fiscal year ending December 31, 2008 and declaring an emergency. (3rd Reading)

Motion to vote on passage made by Ms. Cox, seconded by Mr. Locker. Roll call, 7 yeas, ordinance passed.

- 10-2008 An ordinance authorizing the Director of Public Service to advertise for bids, receive bids, and enter into a contract with the lowest and best bidder to provide the City of New Philadelphia, Ohio with a state approved sanitary landfill facility and solid waste water disposal site for the receipt and disposal of all solid waste and semi-solid waste of the municipality for a period of one year commencing ______ and to receive alternate bids for a contract for a period of three years commencing ______ and appropriating money therefore and declaring an emergency. (1st Reading)
- 11-2008 An ordinance by the Council of the City of New Philadelphia authorizing and directing the Safety Director to advertise for bids, receive bids and to enter into a contract with the lowest and best bidder for the purchase of three (3) motor vehicles properly equipped for use in the Police Department, and declaring an emergency. (1st Reading)

9-2008 A resolution by the Council of the City of New Philadelphia, Ohio to enter into an agreement with the Goshen Township Trustees to permit real estate taxes pursuant to Ohio Revised Code Section 709.023 for the annexation of an adjacent 5.12 acre tract of land located in Goshen Township to remain with the Township for real estate taxes for a period of fifteen (15) years in the amount of sixty percent (60%) and authorizing annexation of this tract, and declaring an emergency. (1st Reading)

Motion to suspend the rules made by Mr. Houston, seconded by Mr. Maurer. Roll call, 7 yeas, rules suspended. Mr. Maurer to explain the importance of suspending the rules. Mr. Johnson said, in order for Rico Pietro, 14281 Sweetbriar Lane, Cleveland, Ohio said there is a deadline for certain government services.
