SPECIAL COMMITTEE. MR. TOM LOCKER

Reported meeting tonight prior to regular session to discuss Ordinance 13-2001, prohibiting dangerous animals. The Committee recommends passage tonight. Also discussed was a request to recognize Jeanette Jenkins for her service to the City for her work at the Airport. The Committee recommends that donations be taken in the Mayor's office for a plaque, and to have the Law Director draft a resolution commending her for years of service. Ms. Cox made a motion to amend Ordinance 13-2001. Motion was seconded by Mr. Day. Roll call, 6 yeas, motion passed.

VISITOR'S COMMENTS:

Ella Slough, 616 Sandpiper, S.E., New Philadelphia, asked why there is such a bad odor coming from the wastewater treatment plant. Service Director Gary Espenschied said he would have Wastewater Treatment Plant Superintendent Jim Dinger call Ms. Slough and explain the problem. Mayor Brodzinski said this has been a problem over the last several years, but upgrading there should relieve the problem. Ms. Slough asked if there is an outside telephone at the airport for use during an emergency. Jim Locker said a telephone has been installed inside the walk-in area for pilots, because there was too much vandalism there for an outside phone booth. Mr. Houston also explained that there was not enough use of the phone to warrant the cost of having a phone in place.

14-2001 An ordinance amending the zoning ordinance by dispersing sexually oriented businesses and limiting them to a specified zoning district; prescribing definitions of sexually oriented businesses; providing for licensing and regulation of sexually oriented businesses and employees; providing for additional miscellaneous regulations for sexually oriented businesses as Chapter 784 of the New Philadelphia Codified Ordinance and repealing existing Chapter 784. (3rd Reading)
