VISITOR'S COMMENTS:

Eric Reip, 1103 Baltzley Valley Rd., New Philadelphia, said he is opposed to the Muskingum Watershed Conservancy District assessments, and the public is not given permission to give comments. Councilman DarrIn Lautenshleger, Public Information Representative of MWCD, said the City does not have authority over MWCD. He pointed out that everyone is given opportunity to speak.

James M. Jones, 233 4th Dr. NW, New Philadelphia, asked what the alternative plan is should the sanitation levy not pass. Council President Dave Johnson said that a fee for trash pickup would likely be added to the water bills.

Larry Arnold, 526 Avon, New Philadelphia, said he understands that the current 2 levies will go off. Law Director Mike Johnson explained that the current two 1-mill levies will be replaced by a 3.7 mill levy. Mr. Arnold said he thought the Mayor's plan to add the sanitation increase to the water bills was the proper way to fund the sanitation. President Johnson said that will be decided should the levy not pass.

Charles Warner, 406 Springbrook, New Philadelphia, asked the status of the sump hole on Springbrook Dr. Mayor Brodzinski said the property owner refuses to give access to the sump hole in order to clean it up. The Law Director said he has contacted her attorney, with no result. Mr. Warner asked what the alternative plan is. Mayor Brodzinski said the city may have to take the property owner to court.
