Reported that he is working with Prestige Creative Marketing on creating a video project about New Philadelphia to use as an economic development tool. He is also working with Prestige to give the city's website a makeover to improve its appearance for the public. Prestige will be paying the city a fee, which could be used to supplement economic development activities for 2009. the Cemetery Department, and thanked him for his service.
