Councilman Robert Conner said more planning is necessary for the city, and he will vote against Ordinance 39-2006.

Councilman Rob Maurer said he favors the ordinance because not many people have voiced their opposition to him. He said many in his ward are in favor of it. Councilwoman Sandy Cox said she is against spot zoning and she believes that the majority of the residents aren't in favor of it, and she will vote against Ordinance 39-2006. Councilman Jimmy Eichel said the City needs to work together to prevent future problems such as this, but he supports this ordinance.
