

ORDINANCE NO. 23-2024

AN ORDINANCE BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, TUSCARAWAS COUNTY, OHIO, AUTHORIZING THE AUDITOR TO ESTABLISH A NEW FUND, CALLED THE "DOWNTOWN QUADRANT MAINTENANCE FUND" NUMBER 282, AND DECLARING AN EMERGENCY.

WHEREAS, The Mayor of City of New Philadelphia wants to establish a new fund. To wit: the "Downtown Quadrant Maintenance Fund" Number 282, to provide funds for downtown quadrant maintenance and repair pursuant to the terms of the Appalachian Development Grant the City received from the Governor's Office of Appalachia; and

WHEREAS, The City of New Philadelphia intends to fund the "Downtown Quadrant Maintenance Fund" Number 282 from the proceeds of the current lease on the building located at 444 Bank Lane Ave SW, New Philadelphia, Ohio with 70% of the proceeds to go to the "Downtown Quadrant Maintenance Fund" Number 282 to fund downtown quadrant maintenance and repairs pursuant to the Appalachian Development Grant the City received from the Governor's Office of Appalachia;

WHEREAS, These types of funds are authorized under Ohio Revised Code Section 5705.12;

NOW THEREFORE BE IT ORDAINED by the Council for the City of New Philadelphia that:

SECTION 1: In accordance with Ohio Revised Code Section 5705.12 the Auditor is authorized to establish a fund called the "Downtown Quadrant Maintenance Fund," Number 282, to be funded by 70% of the proceeds from the lease on the building located at 444 Bank Lane Ave. SW, New Philadelphia, Ohio for the purposes of providing funding for the maintenance and repairs to the downtown quadrant pursuant to the Appalachian Development Grant the City received from the Governor's Office of Appalachia.

SECTION 2: A copy of this Ordinance shall be forwarded to the Auditor of State.

SECTION 3: This Ordinance is hereby declared to be an emergency measure and its immediate passage is necessary in order to preserve, protect and maintain the health, safety and welfare of the citizens of the City of New Philadelphia, Ohio.

SECTION 4: This ordinance shall be in full force and effect immediately upon passage.


