

ORDINANCE NO. 24-2022

AN ORDINANCE BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO, AMENDING AND ADJUSTING THE PERMANENT APPROPRIATIONS ORDINANCE FOR THE YEAR 2022 AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, OHIO, AS FOLLOWS:

SECTION 1. That the 2022 Permanent Appropriations Ordinance is hereby amended by the following supplemental appropriation.



SECTION 3. This Ordinance shall take effect and be in force immediately upon its passage and approval.


