

RESOLUTION NO. 19-2023

A RESOLUTION BY THE COUNCIL OF THE CITY OF NEW PHILADELPHIA, TUSCARAWAS COUNTY, OHIO, AUTHORIZING AND DIRECTING THE MAYOR OF THE CITY OF NEW PHILADELPHIA TO ACT AS THE SIGNATURE DESIGNEE AND TO SUBMIT A GRANT APPLICATION TO THE OHIO DEPARTMENT OF TRANSPORTATION, OFFICE OF AVIATION IN THE AMOUNT OF \$144,606.00 FOR THE PARALLEL TAXIWAY A RELOCATION PROJECT AND ONCE THE GRANT OFFER IS RECEIVED FROM THE OHIO DEPARTMENT OF TRANSPORTATION, OFFICE OF AVIATION, FURTHER AUTHORIZING THE MAYOR TO ACCEPT AND EXECUTE THE GRANT CONTRACT AND ALL RELATED DOCUMENTS AND TO MANAGE THE GRANT AS NECESSARY INCLUSIVE OF SUBMISSION OF APPLICATION FOR PAYMENT ASSOCIATED WITH THE GRANT AS REQUIRED BY THE OHIO DEPARTMENT OF TRANSPORTATION, OFFICE OF AVIATION, AND DECLEARING AN EMERGENCY.

WHEREAS; the existing parallel taxiway A at Harry Clever Field is in need of improvements. The parallel taxiway A separation to Runway 1 5-33 is currently 135 ' and does not meet the required standard separation of 150' for A/B-1 small airports. Per ODOTs inspection in 2016, the PCI of the taxiway was 63. This project will also involve relocating taxiway connectors C and D, installing new taxiway LED edge lights and directional signs to coincide with the new taxiway geometry. The Ohio Department of Transportation, Office of Aviation, is accepting applications for the SFY2024 Grants offered through the Ohio Airport Improvement Program, and

WHEREAS; the council of the city of New Philadelphia Ohio desires to submit an application for funding and execute the Grant contract and any related documents for the SFY2024 Grant Funds under the Ohio Airport Improvement Program.

NOW THEREFORE, BE IT RESOLVED BY THE CITY OF NEW PHILADELPHIA, OHIO, AS FOLLOWS:

SECTION I. The Mayor of the City of New Philadelphia is hereby authorized and directed to act on behalf of the City of New Philadelphia as a signature designee of the City and to submit the Grant application to the Ohio Department of Transportation, Office of Aviation in the amount of \$144,606.00 for the Parallel Taxiway A relocation project and once the Grant offer is received from the Ohio Department of Transportation, Office of Aviation the Mayor is further authorized to accept and execute the Grant contract and all related documents and to manage the Grant as necessary inclusive of submission of application for payment associated with the Grant as required by the Ohio Department of Transportation, Office of Aviation.


SECTION 2, This Resolution shall take effect and be in force immediately upon its passage and approval.
